The Barnet (Burnt Oak Controlled Parking Zone) (Parking Places) Traffic Order 20**

The Barnet (Waiting and Loading Restriction) (Special Parking Area) (Amendment No. ***) Traffic Order 20**

The Barnet (Disabled Persons Parking Places) (No.1) (Amendment No. **) Traffic Order 20**

NOTICE IS HEREBY GIVEN that the Council of the London Borough of Barnet propose to make the above-mentioned Orders under Sections 6, 45, 46, 49, 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.

In order to address various parking issues in the area, and effectively manage parking on the highway, taking into account the parking demands from residents of, visitors to and workers of the area, the general effect of the Orders would be to introduce Controlled Parking Zones in the Burnt Oak area to include the streets or part of streets detailed in Schedule 1 below:

Schedule 1:

BU1 Controlled Parking Zone – Monday to Saturday, 8am to 6.30pm

Abbots Road, Edgware (between Orange Hill Road and No. 22 Abbots Road); Back Lane, Edgware; Barnfield Road, Edgware; Blessbury Road, Edgware; Blundell Road, Edgware (between Montrose Avenue and No. 146 Blundell Road); Boston Road, Edgware; Brearley Close, Edgware; Briar Walk, Edgware; Colchester Road, Edgware; Cressingham Road, Edgware (between Watling Avenue and Abbots Road); Fortescue Road, Edgware; Gaskarth Road, Edgware; Gervase Road, Edgware; Gilbert Grove, Edgware; Gloucester Grove, Edgware; Gunter Grove, Edgware; Hook Walk, Edgware; Kirton Walk, Edgware; Langham Gardens, Edgware; Langham Road, Edgware; Littlefield Road, Edgware; Market Lane, Edgware; Millfield Road, Edgware; Montrose Avenue, Edgware; Mostyn Road, Edgware; Norwich Walk, Edgware; Orange Hill Road, Edgware; Park Croft, Edgware; Pavilion Way, Edgware; Playfield Road, Edgware; Silkstream Road, Edgware; St.Alphage Walk, Edgware; Thirleby Road, Edgware; Trevor Gardens, Edgware; Trevor Road, Edgware; Trueman Close, Edgware; Watling Avenue, Edgware (between A5 Burnt Oak Broadway and Goldbeaters Grove)

BU2 Controlled Parking Zone – Monday to Saturday, 8am to 6.30pm

Greenway Close, Edgware; Greenway Gardens, Edgware; Portman Gardens, Edgware Southbourne Avenue, Edgware; The Greenway, Edgware

BU3 Controlled Parking Zone – Monday to Saturday, 8am to 6.30pm

Burnt Oak Fields, Edgware; East Road, Edgware; North Road, Edgware; South Road, Edgware

The Parking Places Order would provide resident permit parking places, pay and display parking places, and 'dual use' resident permit and pay and display parking places which would indicate by the appropriate signage their use during their controlled hours by vehicles displaying either a valid resident permit, visitor voucher or a pay and display ticket as appropriate. Loading and unloading in these parking places would be permitted without the need to display a permit, pay and display ticket or visitor voucher for up to forty minutes, provided that the loading and unloading is seen to be continuous.

The Parking Places Order would also amend the existing pay and display parking places on Watling Avenue, Edgware which currently operate Mondays to Saturdays, 9am to 5.30pm, so that they would operate Mondays to Saturdays 8am to 6.30pm.

Vehicles displaying disabled persons blue badges and motorcycles are exempt from all parking charges. Resident permits cost £40 per year for the first vehicle and £70 each for the second and third vehicles. A maximum of three valid permits are allowed per household. Visitor vouchers cost £10 per book of ten vouchers, with a maximum of 20 books per household per year. BU1, BU2 and BU3 resident permits and visitor vouchers are valid throughout their respective Controlled Parking Zone areas. Addresses which would be eligible for the issue of resident permits and visitor vouchers would be any address which falls within the streets or lengths of street detailed in Schedule 1 to this notice in addition to the addresses detailed in Schedule 2 below:

BU1 Residents Permits and Visitor Vouchers

Botham Close, Edgware, all properties; Bradman Row, Edgware, all properties; Burnt Oak Broadway (Nos. 92 to 156 even, including 1-12 Montrose Court, Colesworth Court, Crokesley House, Curtlington House, Clare House and Kedyington House); Compton Close, Edgware, all properties; Gatting Close, Edgware, all properties; Hutton Row, Edgware, all properties

BU2 Residents Permits and Visitor Vouchers

The Hyde, Edgware (13-24 Montrose Court, Millett House, Southbourne Court and Imperial House)

BU3 Residents Permits and Visitor Vouchers

Burnt Oak Broadway, Edgware, (Nos. 158 and 218 Burnt Oak Broadway, even, including Appletree Court); Cooms Walk, Edgware, all properties; Copinger Walk, Edgware, all properties; Fell Walk, Edgware, all properties; Newton Walk, Edgware, all properties; Roscoff Close, Edgware, all properties; The Croft, Edgware, all properties

The fees for pay and display parking would be:-

Up to 15 minutes	£0.30
Up to 30 minutes	£0.50
Up to 45 minutes	£0.80
Up to 1 hour	£1.50
Up to 90 minutes	£2.50

Long stay pay and display parking places would allow motorists to park for longer than 90 minutes and for this a charge of £3 would apply.

The Waiting and Loading Restriction Order would introduce yellow lines restrictions where parking places are not provided in certain lengths of road in the relevant areas, which would restrict parking at all times (generally at junctions) or during the hours that the particular CPZ operates. In addition, the Waiting and Loading Restriction Order would:

- upgrade existing Monday to Saturday 8am to 6.30pm waiting restrictions to 'at any time' waiting restrictions on certain lengths of Back Lane, Edgware; Gaskarth Road, Edgware; Barnfield Road, Edgware; Market Lane, Edgware; Silkstream Road, Edgware, Watling Avenue, Edgware.

- upgrade existing Monday to Saturday 7am to 10am, 4pm to 7pm waiting restrictions to 'at any time' waiting restrictions on certain lengths of North Road, Edgware; A5 Burnt Oak Broadway, Edgware; Southbourne Avenue, Edgware; A5 The Hyde, Edgware and Greenway Gardens, Edgware
- upgrade existing Monday to Saturday 7am to 10am, 4pm to 7pm waiting restrictions to Monday to Saturday 8am to 6.30pm waiting restrictions on North Road, Edgware
- remove certain lengths of Monday to Friday 8am to 9.30am waiting restrictions on Gaskarth Road, Edgware
- remove certain lengths of Monday to Saturday 8am to 9am, 5pm to 6.30pm waiting restrictions on Watling Avenue, Edgware.

The Disabled Persons Parking Places Order would provide new, and relocate existing parking places for vehicles displaying a valid blue disabled badge, as follows

Watling Avenue, Edgware (2 outside the medical centre), No.1 Colchester Road, Edgware, Fortescue Road, Edgware (relocation of existing disabled persons parking place), Goldbeaters Grove, Edgware (relocation of existing disabled persons parking place).

Business Permits – Watling Avenue Car Park

In order to be of assistance to businesses who need to be able to park vehicles in the area in order to enable trade, businesses who retail trade within the area specified in Schedules 1 and 2 to this notice, would be eligible to apply for business permits which would allow them to park within the majority of spaces within the Watling Avenue Car Park during its controlled hours of Mondays to Fridays, 9am to 5.30pm. Business Permits cost £300 per year, and a maximum of 3 valid permits are allowed per business.

A copy of the proposed Orders, a plan of the proposed Controlled Parking Zones (CPZs) and the Council's Statement of Reasons for proposing to make the Orders can be inspected between 9am and 5pm on Mondays to Fridays (Public and Bank Holidays excepted) inclusive for a period of 21 days from the date on which this notice is published at:

Any person wishing to object to the proposed Orders should send a written statement explaining their objection to the Design Team at the address above within 21 days of the date of this Notice.
