The Corporate Anti Fraud Team (CAFT) is a specialist investigative unit within the Corporate Governance Directorate which investigates all allegations of Internal Fraud, Housing Benefit and Council Tax Benefit Fraud within the London Borough of Barnet.

Our aim is to assist the Council in protecting the public purse through the facilitation of sound strategies, procedures and controls in the prevention, detection, investigation and deterrence of fraud and corruption.

It has always been a clear objective of the Corporate Anti Fraud Team to ensure that through our investigations all intelligence gathered is collated and circulated to all the relevant anti-crime teams to assist with their partnership working and a more intelligence led approach to crime and disorder. This is aimed at promoting and improving the safety of the community.

## Responsibilities of the Corporate Anti Fraud Team are:

- To Investigate all allegations of Internal Fraud and corruption.
- To Investigate all allegations of Housing and Council Tax Benefit Fraud.
- To provide the specialist skills of accredited financial investigators, which will assist and protect the authority in the investigation of any allegations of money laundering offences.
- Solving the problem of the Misuse of Disabled Blue Badge Fraud within the London Borough of Barnet.
- Providing a dedicated Intelligence Team.
