NOTICE IS HEREBY GIVEN that the Council of the London Borough of Barnet propose to make the above mentioned Orders under sections 6, 45, 46, 49 and 51 to the Road Traffic Regulation Act 1984 and all other enabling powers.

The general effect of the Orders would be to provide or remove redundant disabled parking bays for vehicles displaying a valid disabled Blue Badge at the following locations:

### **New disabled parking bays operational, at any time, for vehicles displaying a valid Blue Badge:**

51 Balfour Grove N20, 20 Brunswick Crescent N11, 9 Cromer Road Barnet, 12 Grove Road Barnet, 116 Long Lane N3, 23 Prospect Road Barnet, outside 14 to 24 Saffron Close NW11 and 109 Squires Lane N3.

### **Redundant disabled parking bays:**

It is also proposed to remove the following redundant disabled parking bays and where noted convert to permit parking places:

63 Brookland Rise NW11, 55 East Walk Barnet, 17 Hadley Highstone Barnet, 31 Holly Park Road N11, 59a Huntingdon Road N2 (converted to General Permit parking place), 13 Marlborough Close N20, 24 Parkhurst Road N11, 16 Saffron Close NW11 (converted to Resident Permit parking place), 62 St Georges Road NW11 (converted to Resident Permit parking place), 77 Wentworth Road NW11 (converted to Resident Permit parking place), 79 Wentworth Road NW11 (converted to Resident Permit parking place) and 8 Woodlands Court Woodlands NW11.

A copy of the proposed Orders, plans of the relevant locations and the Council's Statement of Reasons for proposing to make the Orders can be inspected between 9am and 5pm Mondays to Fridays (Public and Bank Holidays excepted) inclusive for a period of 21 days from the date on which this notice is published at:
