INSTAGRAM LOGO DESIGN COMPETITION

TERMS AND CONDITIONS

1. The Instagram logo design competition is open to all London Borough of Barnet residents aged 13 to 25 years old.
2. The competition is free to enter and no purchase is necessary. The entries submitted that fit the competition brief will be automatically entered into the competition.
3. Only one entry per person is permitted. All entries must be submitted by emailing the logo design in either a JPEG or PDF format via email to danielle.gopie@barnet.gov.uk.
4. The closing date of the competition is **9am on Monday 12 October 2020**. Entries received after this time will not be considered.
5. London Borough of Barnet accepts no responsibility for entries not successfully submitted via email due to a technical interruption, network or server failure, London Borough of Barnet does not take any responsibility for incomplete submissions (e.g. not including the correct letters and character in your design) and any incomplete submissions will not be considered valid for entry into the competition. London Borough of Barnet accepts no responsibility for any submissions which are not completed for any reason.
6. A winner, runner-up and 3rd place finalist will be chosen by a panel of judges based on the applicant's ability to accurately follow the brief provided in the competition advert as well as the creativity and quality of their design.
7. The winner will receive an Amazon gift voucher worth £250, a one-to-one session with a professional graphic designer and will have their logo design used for BarnetYouth_ Instagram official branding. The runner up will receive an Amazon gift voucher worth £150 and the 3rd place finalist will receive an Amazon gift voucher worth £100.
8. The winner, runner up and 3rd place finalist will be announced on BarnetYouth_ Instagram page on Friday 16 October and all 3 finalists will be contacted by email on this date as well. The finalists must confirm within 7 days via email that they are able to receive their Amazon gift voucher electronically. If the finalist does not respond to the email within 7 days, then their prize will be forfeited, and London Borough of Barnet will be entitled to select another winner in accordance with the process described above.
9. The winner will be emailed proposed dates and times for a one-to-one training session with our graphic designer and the winner must respond within 7 days to confirm their availability. Once the winner confirms the date and time of the session that he/she can attend this cannot be rearranged.
10. The winner's design will be used for BarnetYouth_ Instagram future branding however no date has been decided on when this will launch. London Borough of Barnet will keep the winner informed via email on when they can expect to see the official BarnetYouth_ Instagram branding updated with their design.

11. The prizes for the winner, runner up and 3rd place finalist are non-exchangeable, non-transferable and no cash alternative is offered.
12. The prize is supplied by London Borough of Barnet who reserve the right to replace the prize with an alternative prize of equal or higher value if circumstances beyond the London Borough of Barnet's control makes it necessary to do so.
13. The decision of the London Borough of Barnet regarding any aspect of the competition is final and binding and no correspondence will be entered into about it.
14. Participants are deemed to have accepted and agreed to be bound by these terms and conditions upon entry. London Borough of Barnet reserves the right to refuse entry, or refuse to award the prize to anyone in breach of these terms and conditions.
15. London Borough of Barnet reserves the right to hold void, cancel, suspend, or amend the promotion where it becomes necessary to do so.
16. Insofar as is permitted by law, London Borough of Barnet, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of London Borough of Barnet, its agents or distributors or that of their employees. Your statutory rights are not affected.
17. Finalists may be asked if they would like to participate in publicity related to the competition, which may include the publication of their name and photograph in any media.
18. Personal data supplied during the course of this promotion may be passed on to third party suppliers only insofar as required for fulfilment/delivery/arrangement of the prizes.
