Return to Reg 19 text of GSS13 (i.e. remove MM112 text about the sports hubs ) and add: “according to policy G4 of the London Plan” in the third paragraph.	Encourages overdevelopment on green spaces. Allowing buildings on green space makes it into ‘brownfield’ and encourages further development. Cophall Fields are already very developed, with a large stadium and leisure centre and several car parks. Replace paragraph e) by: Barnet should refrain from building on sites which are currently parks, playing fields or Green Belt. Such spaces could be protected by designating them as Local Open Spaces.	It is very welcome that the use of the words ‘low value’ and ‘low quality’ with regard to green spaces has been removed, but the updated version (see modification MM270) is not clear about protecting green spaces and playing fields from development.  Parks such as Whalebones Park and Sunny Hill Park should be designated as a Local Open Space.

Barnet Council already has the detailed information in order to provide the summaries above; therefore with the aim of transparency, it is perfectly reasonable for them to make this data available to the public.</p> <p>This is especially Important where money collected is invisible e.g. cash-in-lieu payments.</p>

<b>2g</b>	CHW01 iii	Not robust. Possible loophole. Could lead to lower infrastructure provision.	Remove paragraph iii	The modification MIM49 appears to have removed the sentence “and that there is no undue impact on the amenity of existing residents or the highway network;” Without this sentence, the paragraph might be used to justify a lower provision of facilities and services. With an increasing population this will lead to a lower level of public amenity and lower standard of living.
