### 1. INTRODUCTION, WELCOME AND APOLOGIES

### 4. BPSI- NEW SERVICES AVAILABLE: GOVERNANCE REVIEWS AND A PUPIL PREMIUM REVIEW

Richard Griggs, BPSI Manager, gave an introduction to the new Barnet Partnership for School Improvement (BPSI) services available.

John Paxton, Narrowing the Gap Advisor/Lead NQT Adviser, gave a presentation

(attached) on the Pupil Premium Review, which is one of the services available from BPSI.

# 5. PROVISION OF ADDITIONAL SCHOOL PLACES FOR SEPTEMBER 2015 – UPDATE

Alison Dawes, Head of Education Partnerships and Commercial Services, gave an update on School Place Planning (Powerpoint Presentation attached). Reference was made to the School Admission Arrangements 2017/18 letter that had been circulated to schools on 30 September 2015 (attached), and the Timetable for the consultation of School Admission Arrangements 2017/2018 (attached).

### 6. SCHOOL AUDITS

Caroline Glitre, Head of Internal Audit (Assurance Group) advised that The Council's Internal Audit service had undertaken a piece of work with the School Improvement Service to expand the areas of audit to further support schools, and that Internal Audit were undertaking a pilot of additional audit areas in the Autumn term to include:

- Pupil Premium
- An expansion of the current audit testing around Governance
- High level testing on pre-employment checks and Safegarding policies / reporting
- Anti-fraud controls

To support the pilot a self-assessment checklist would be provided and Internal Audit would be requesting that this be completed by Headteachers with the support of the Chair of Governors and Schools Business Manager. Co-operation with the pilot of additional audit areas is much appreciated.

### 7. SCHOOL BUDGET ISSUES

### The School Funding Formula and FSM eligibility checks

Ian Harrison, Education and Skills Director, referred to a letter circulated to schools approximately three weeks previously about the school funding formula and our new FSM eligibility service.

Governors were reminded that, if they had not yet responded to the consultation on the changes to the school funding formula, then please do so.

Furthermore, there were still some schools that had not yet signed up to the Free

School Meals Eligibility Service. Governors were urged to consider this as a matter of urgency. The process enabled the LA to identify pupils who were eligible for Pupil Premium funding, who were otherwise missed from the calculations, meaning access to thousands of pounds extra for some schools.

### 8. EFFECTIVE GOVERNANCE AUDIT

Neil Marlow, Head of School Improvement, gave a presentation (attached) about the Effective Governance Audit.

Governors would like all maintained schools to complete and return this Audit to Sarah Beaumont at sarah.beaumont@barnet.gov.uk as soon as is convenient, and by Friday 23 October 2015 if at all possible.

Responses from academies and free schools were welcomed. Governors were advised that every audit would be evaluated individually and that feedback, advice and training opportunities where appropriate would be offered. The Effective Governance Audit was planned to become an annual process with subsequent audits just asking for updates on previous information submitted.

Further support can be arranged by BPSI and Governor Services. BPSI hours can be used for some of this training.
