This Plan contains a proposal to allegedly "improve access" between Colindale Park and Rushgrove Park "by utilising land between Northern Line and the Silkstream for a new pedestrian and cycle route within a new open space."

The proposed pedestrian and cycle route will inevitably encroach on wild-life habitat on and around the Silkstream River. This habitat currently supports squirrels, foxes, and an array of bird life including ducks, egrets, herons, woodpeckers, magpies and crows.


