The proposed number of new homes (1,400) is excessive for the area shown on Map 3B Cricklewood Growth Area (containing sites 7 and 8) and cannot be achieved without creating tall or very tall buildings (as defined in policy CDH04) which would be out of keeping with the area.

It should be mentioned that the B&Q site sits on a raised area of former railway sidings that is several feet above the ground level of the surrounding streets which is to be the benchmark for the start of height measurement.

Furthermore, this proposed number of new homes does not respect either the historical and archaeological importance of Cricklewood, nor the conservation area of the Railway Terraces.

Intensification of housing in this area would contradict Barnet's stated objective of drawing upon the legacy of Raymond Unwin (section 2.3.3)

Valuable local amenities – health clinic, supermarket, historic pub (Lucky 7), building home improvement – could not coexist with this enormous number of new homes proposed
